# **Online Privacy Statement**

#### Overview

Western Union Business Solutions (USA), LLC (alternately, "Western Union Business Solutions", "WUBS", "we", "us" or "our") respects your privacy and is committed to complying with this privacy policy ("Online Privacy Statement"), which describes what information we collect about you, including how we collect it, how we use it, with whom we may share it, and what choices you have regarding our use of your information. This Online Privacy Statement applies to information collected on our website located at http://business.westernunion.com (the "Website"), any current or future mobile applications associated with the Website (the "Mobile Applications"), all interactive features, applications, widgets, social networks and social network "tabs," and other online or wireless offerings that post a link to this Online Privacy Statement, whether accessed via computer, mobile device, or other technology or any associated content, material, or functionality contained on the Website or Mobile Application (collectively, the "Services" and, together with the Website and the Mobile Application, the "System"). By accessing and using the System, or any part thereof, you agree that you have read and understand this Online Privacy Statement, and that in exchange for access to the System, you accept and consent to the privacy practices (and any uses and disclosures of information about you) that are described in this Online Privacy Statement. The U.S. Consumer Privacy Notice, which applies to U.S. customers and consumers as described in that notice, may apply in addition to the terms of this Online Privacy Statement. In the event that the U.S. Consumer Privacy Notice is applicable but conflicts with any terms of this Online Privacy Statement, the U.S. Consumer Privacy Notice shall govern with respect to those conflicting provisions.

# **Changes to our Online Privacy Statement**

We may change this Online Privacy Statement at any time and from time to time. The most recent version of the Online Privacy Statement is reflected by the version date located at the top of this Online Privacy Statement. All such updates and amendments are effective immediately upon notice thereof, which we may give by any means, including, but not limited to, by posting a revised version of this Online Privacy Statement or other notice on the System. You should view this Online Privacy Statement often to stay informed of changes that may affect you, as your continued use of the System signifies your continuing consent to be bound by this Online Privacy Statement. We expressly reserve the right to make any changes to this Online Privacy Statement at any time, without prior notice to you. On each respective date you visit the System this Online Privacy Statement shall be the Online Privacy Statement applicable to your access and use of the System on that date. Our electronically or otherwise properly stored copies of this Online Privacy Statement shall be deemed to be the true, complete, valid, authentic, and enforceable copy of the version of this Online Privacy Statement which were in force on each respective date you visited the System. This Online Privacy Statement is not intended to and does not create any contractual or other legal right in or on behalf of any party other than Western Union Business Solutions.

## What Information Do We Collect?

As described in detail below, we may collect certain identifying information from or about you in connection with your use of, or your submissions to, the System (collectively, the "Collected Information"). Collected Information includes, without limitation, any information that may be used to identify an individual, including, but not limited to; a first and last name; a home, business, or other physical address; business name; a phone number; an email address; employer name; and employer information (i.e.,

employer address and other identifying information). Western Union Business Solutions uses the information we collect to provide the Western Union Business Solutions Services that are available via the System. In order to continuously improve your service and tailor our subsequent communications to you, we may also ask you to provide us with additional information regarding your demographics, comments, professional interests, and contact preferences.

# **Internet Technology and Internet-based Advertising**

Western Union Business Solutions, its service providers, and other third parties may use technologies such as cookies, pixels and web beacons to collect information such as browser type, operating system, network information, time spent on the website or mobile app, pages visited, language preferences, and your relationship with us. We use this information for a variety of purposes, including, but not limited to, the following: statistics collection and analysis, System optimization, analytics, market research, and maintenance of user login information. The information that we and our third party service providers track with cookies includes, but is not limited to, the type of browser (such as Google Chrome or Internet Explorer) and internet-connected devices being used to access the System, your internet protocol ("IP") address, your home domain or internet service provider, your referrer URL (which is the URL for the website that you were viewing prior to visiting the System), how you were directed to the System, which specific pages you access on the System, how long you view each page, the time and date you access our System, and the total number of visitors to the System and any portions thereof. We, and/or our third party service providers, may use the information collected from cookies or similar files on your computer for security purposes (such as authentication), to facilitate site navigation and to personalize your experience while visiting the System. This data helps us and our third party service providers improve our respective product and services. Most popular internet browser applications will allow you to configure the browser so as not to accept cookies. However, setting your browser to reject cookies may, in certain instances, prevent you from taking full advantage of the System (or some portion thereof) and its capabilities, or cause some features of the System to function improperly or more slowly. Our Website may also use web analysis services in order to better understand your use of our Website and how we can improve it.

We also have relationships with advertising companies, who may use cookies, pixels, web beacons, app or device information or related information to display advertising tailored to your interests or location. # **Online Account Management**

If you elected to subscribe to any online services provided via the System, including the ability to access any password-protected areas of the System, you will be required to submit personal information (including some Collected Information) for the purpose of verifying your identity and your authority to manage the account. This Collected Information will be used exclusively by Western Union Business Solutions, our agents, suppliers, and third-party service providers for internal use and to respond to your service requests.

### **How Do We Use The Information That We Collect?**

Western Union Business Solutions and our third party service providers collect and use the Collected Information to operate the System and deliver the Services, including to provide certain services and to improve the user experience, address System integrity or security issues, and conduct research and analysis to maintain, protect, develop, and improve the System and, additionally, use any information submitted by users as described below or elsewhere in this Online Privacy Statement. We may send you information that you request from us, promotional materials regarding Western Union Business Solutions, and any other communication for any other legitimate and lawful business purposes. Additionally, we may retain and use certain Collected Information to facilitate and otherwise address certain inquiries or requests regarding the Services or the System, or respond to your questions or requests for information about or from Western Union Business Solutions. We may also use Collected Information as necessary to ensure compliance with any Western Union Business Solutions policies and any applicable law, regulation, or order.

Except as set forth in this Online Privacy Statement, Western Union Business Solutions will not use, disclose, or transfer your Collected Information unless:

- (1) you expressly authorize Western Union Business Solutions to do so;
- (2) it is necessary to allow Western Union Business Solutions' service providers, agents, or other third parties to provide products or services for or to Western Union Business Solutions;
- (3) it is necessary in order to provide the System or the Services;
- (4) Western Union Business Solutions is sending you other information that may be useful to you;
- (5) subject to applicable contractual or legal restrictions, it is disclosed to entities that perform marketing services on Western Union Business Solutions behalf or to other entities with whom Western Union Business Solutions has joint marketing agreements;
- (6) it is necessary to protect the confidentiality or security of your records;
- (7) it is necessary in connection with other business purposes including, without limitation; verifying identity or age; investigating complaints about the System; risk assessment; security, fraud, and crime prevention/detection, monitoring, research and analysis; marketing; customer purchasing preferences and trends; and dispute resolution;
- (8) it is necessary to comply with law enforcement, governmental mandate, or other legal requirement, if appropriate, for your protection or in connection with an investigation or prosecution of possible unlawful activity;
- (9) subject to applicable contractual or legal restrictions, it is necessary in connection with a sale of all or substantially all of the assets of Western Union Business Solutions or the merger of

- Western Union Business Solutions into another entity or any consolidation, share exchange, combination, reorganization, or like transaction in which Western Union Business Solutions is not the survivor; or
- (10) it is otherwise necessary for Western Union Business Solutions to disclose it as required or permitted by law.

## With Whom Do We Share Information That We Collect?

In addition to information sharing described elsewhere in this Online Privacy Statement, we may also disclose Collected Information if we become subject to a subpoena or court order, or if we are otherwise legally required to disclose information. We may also use and disclose Collected Information to establish or exercise our legal rights, to assert and defend against legal claims, or if we believe such disclosure is necessary to investigate, prevent, or take other action regarding actual or suspected illegal or fraudulent activities or potential threats to the physical safety or well-being of any person.

It is possible that Western Union Business Solutions' corporate structure or organization might change or that it might merge or otherwise combine with, or that it or portions of its business might be acquired by, another company. In any such transactions, customer information generally is, and should be expected to be, one of the transferred business assets. Also, if any bankruptcy or reorganization proceeding is brought by or against us, your information may be considered a company asset that may be sold or transferred to third parties.

## What Choices Do You Have?

## Children

The System is intended for a general audience and is not intended for use or view by children under 13 years of age without parental consent, and we do not knowingly collect information about children.
