### What is this Product?

**Type** An over-the-counter (OTC) foreign exchange derivative structure - Leveraged Knock In Reset - Leveraged Knock In Reset Window - Leveraged Knock In Reset At Expiry

**Description:** The Leveraged Knock In Reset is a Structured Option that works in exactly the same way as the non-leveraged variety. It offers protection against the risk that the EURUSD rate will be less favourable than a nominated Protection Rate at Expiry. It also gives you the ability to participate in favourable movements in the EURUSD rate provided that a Knock In Rate is not observed. If the EURUSD rate trades at or beyond the Knock In Rate, then you must deal the Leveraged Amount at a Reset Rate, which would typically be more favourable than a comparable Forward Exchange Contract at the time of entering into the deal.

A Leveraged Knock In - Reset is structured by entering into three concurrent options. In the first you buy a Put Option giving you the right, but not the obligation to deal the Protected Amount with WUIB at the Protection Rate. In the second and third you buy a further Put option and also sell a Call Option to WUIB at the Reset Rate with a barrier at a given Knock In Rate. These options remain dormant and cannot be exercised /exercised against you unless the underlying Spot Rate trades at or beyond the Knock In Rate during the life of the contract. If and when this happens, the original Put option at the Protection Rate ceases to exist and you are left with either the right to deal the Protected Amount if the Spot Rate is less favourable or the obligation to deal the Leveraged Amount if the Spot Rate is more favourable than the Reset Rate at the expiry time on the Expiry Date.

Where applicable, a Window Barrier can only be triggered during a specified period of time, rather than throughout the life of the contract, while an At Expiry barrier can only be triggered at the expiry time on the expiry date
