### What is this Product?

**Type** An over-the-counter (OTC) foreign exchange derivative structure - Collar

**Description:** The Collar is a Structured Option which allows you to protect against the risk that the GBPUSD rate will be less favourable than a nominated worst case rate known as the Protection Rate. It also gives you the opportunity to participate in favourable movements in the GBPUSD rate between the Protection Rate and a given best case rate known as the Participation Rate.

A Collar is structured by entering into two concurrent options. In the first you buy a Put Option from WUIB giving you the right, but no obligation to deal the Protected Amount with WUIB at the Protection Rate. In the second you sell a corresponding Call Option which will oblige you to exchange the Obligated Amount with WUIB at the Participation Rate should the underlying Spot Rate exceed that level at the expiry time on the Expiry Date.

**Intended Retail Investor** This product is suitable for any corporate customer who wants to protect against downside risk without forgoing the ability to participate, to some degree in favourable rate moves. These are also suited to customers who require a less volatile hedging product.

**Term** This Document assumes a term of 3 months, a typical duration for this structure type; however, the term of the contract will be agreed with you when entering into the deal. Once agreed, the buyer retains the right to request cancellation of the contract prior to expiry on demand, although this will incur a cost (see below). Western Union reserves the right to terminate the contract only in circumstances where the buyer is in breach of the contract terms, or becomes insolvent.

The risk indicator assumes you keep the product for 3 months. The actual risk can vary significantly if you end your product at an early stage and you may get back less. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

## What are the costs?

## How long should I hold it and can I take my money out early?

**Recommended holding period** **3 months**

The recommended holding period is the duration of the OTC product as agreed in the individual contract. For this product, a holding period of 3 months is quite common and so has been used as the example; however, if you buy this option the duration should match your underlying cash flow requirements. There is no minimum holding period per se, but the product performs better when held for at least 3 months and the maximum is 24 months.

In general, the option should be held until the maturity date; however, it can be ended early at your request.

Depending on the market value of the product there may be a gain or loss to you at the point of ending the product.
