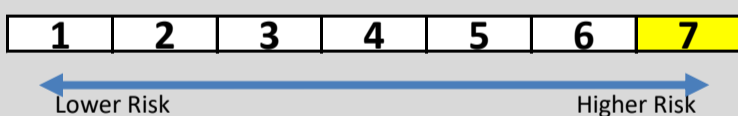

### What is this Product?

<b>Type</b>	<b>This product is an over-the-counter (OTC) option structure</b>
<b>Objectives</b>	<b>Hedging</b>
<b>Description:</b>	The Tracker is a Structured Option which allows you to protect against the risk that EURUSD will be less favourable than a nominated Foreign Exchange Rate (the Protection Rate) at expiry. It also gives you the opportunity to participate in favourable movements in EURUSD up to a pre-determined Participation Rate where that differs from the Protection Rate. If the EURUSD continues to move favourably and exceeds the Tracker Rate, the rate at which you deal will also improve on a like for like basis.
<b>Intended Customer</b>	This product is suitable for any corporate customer who wants to protect against downside risk without forgoing the ability to participate, to some degree in favourable rate moves. These are also suited to customers who require a less volatile hedging product or who prefer to know their worst case scenario in advance.
<b>Term</b>	This Document assumes a term of 3 months, a typical duration for this structure type; however, the term of the contract will be agreed with you when entering into the deal. Once agreed, the buyer retains the right to request cancellation of the contract prior to expiry on demand, although this will incur a cost (see below). Western Union reserves the right to terminate the contract only in circumstances where the buyer is in breach of the contract terms, or becomes insolvent.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 12 months. The actual risk can vary significantly if you end your product at an early stage and you may get back less.

You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on the performance of your product.

The Summary Risk Indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as 7 out of 7, which is the highest risk class.** This rates the potential losses from future market performance at a high level, and poor market conditions are likely to impact the capacity to pay you.

**Be aware of currency risk. You will receive payments in a different currency so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown across.**

In some circumstances you may be required to make further payments to pay for losses. **The total loss you may incur may significantly exceed the amount invested.**

### What are the costs?

The Reduction In Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.
