This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

### What is this Product?

**Type** An over-the-counter (OTC) foreign exchange derivative structure - Leveraged Tracker

**Description:** The Leveraged Tracker is a Structured Option which allows you to protect against the risk that GBPUSD will be less favourable than a nominated Foreign Exchange Rate (the Protection Rate) at expiry. It also gives you the opportunity to participate in favourable movements in GBPUSD up to a pre-determined Participation Rate where that differs from the Protection Rate. If the GBPUSD continues to move favourably and exceeds the Tracker Rate, the rate at which you deal will also improve on a like for like basis.

A Leveraged Tracker is structured by entering into three concurrent options. As an importer, you buy a Put Option from WUIB giving you the right, but no obligation to deal the Protected Amount with WUIB at the Protection Rate. In the second you sell a corresponding Call Option which will oblige you to exchange the Leveraged Amount with WUIB at the Participation Rate should the underlying Spot Rate exceed that level at the expiry time on the Expiry Date. You then buy an additional Call Option at the Limit Rate which limits your obligation at the difference between the Call you sold and the Call you bought. A Tracker always provides you with complete protection at the Protection Rate.

**Intended Retail Investor** This product is suitable only for those corporate customers who have a higher degree of experience of hedging currency risk. As the potential obligation exceeds the amount protected; however, this risk is mitigated by the fact the obligation is capped at the Tracker Rate.

**Term** This Document assumes a term of 9 months, a typical duration for this structure type; however, the term of the contract will be agreed with you when entering into the deal. Once agreed, the buyer retains the right to request cancellation of the contract prior to expiry on demand, although this will incur a cost (see below). Western Union reserves the right to terminate the contract only in circumstances where the buyer is in breach of the contract terms, or becomes insolvent.

**What are the risks and what could I get in return?**

The risk indicator assumes you keep the product for 9 months. The actual risk can vary significantly if you end your product at an early stage and you may get back less. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The Summary Risk Indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as 7 out of 7, which is the highest risk class.** This rates the potential losses from future market performance at a very high level, and poor market conditions are very likely to impact the capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

In some circumstances you may be required to make payments to pay for losses. The total loss you may incur may significantly exceed the amount invested.

**What Happens If Western Union International Bank GmbH is unable to pay out?**

As counterparty to your product you are relying upon WUIB's financial ability to fulfil its obligations to you upon maturity of the contract. **What are the costs?**

The Reduction In Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for the recommended holding period. They include potential early exit penalties. The figures assume a nominal value of EUR 10,000. The figures are estimates and may change in the future.

**How long should I hold it and can I take my money out early?**

**Recommended holding period** **9 months**

The recommended holding period is the duration of the OTC product as agreed in the individual contract. For this product, a holding period of 9 months is quite common and so has been used as the example; however, if you buy this option the duration should match your underlying cash flow requirements. There is no minimum holding period per se, but the product performs better when held for at least 9 months and the maximum is 24 months.

In general, the option should be held until the maturity date; however, it can be ended early at your request.

Depending on the market value of the product there may be a gain or loss to you at the point of ending the product.
