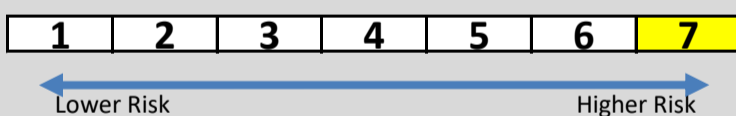

### What is this Product?

<b>Type</b>	<b>This product is an over-the-counter (OTC) option structure</b>
<b>Objectives</b>	<b>Hedging</b>
<b>Description:</b>	The Leveraged Collar is a Structured Option allows you to protect against the risk that the GBPUSD rate will be less favourable than a nominated worst case rate known as the Protection Rate. It also gives you the opportunity to participate in favourable movements in the GBPUSD rate between the Protection Rate and a given best case rate known as the Participation Rate. However, in order to make the Protection Rate and the Participation Rate more attractive at the outset, you agree that, should the GBPUSD rate be more favourable than the Participation Rate at expiry, you will be obliged to deal a larger amount at the Participation Rate.
<b>Intended Customer</b>	This product is suitable only for those corporate customers who have a higher degree of experience of hedging currency risk. As the potential obligation exceeds the amount protected, the buyer should also be in a strong financial situation and/or make use of other, less volatile hedging products in addition to this.
<b>Term</b>	This Document assumes a term of 1 year, a typical duration for this structure type; however, the term of the contract will be agreed with you when entering into the deal. Once agreed, the buyer retains the right to request cancellation of the contract prior to expiry on demand, although this will incur a cost (see below). Western Union reserves the right to terminate the contract only in circumstances where the buyer is in breach of the contract terms, or becomes insolvent.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 12 months. The actual risk can vary significantly if you end your product at an early stage and you may get back less.

You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on the performance of your product.

The Summary Risk Indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as 7 out of 7, which is the highest risk class.** This rates the potential losses from future market performance at a high level, and poor market conditions are likely to impact the capacity to pay you.

**Be aware of currency risk. You will receive payments in a different currency so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown across.**

In some circumstances you may be required to make further payments to pay for losses. **The total loss you may incur may significantly exceed the amount invested.**

### What are the costs?

The Reduction In Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.
